Public Transport: Mrs Stella Potter

Mrs Potter, Chrishall Parish Council's representative on transport reported that all scheduled buses, except for the buses taking children to and from school, will be replaced with 'Demand Responsive Transport' from the 12th April 2016. This system will be run by Arrow Taxis, based in Maldon, Essex. This system should be available Monday to Saturday, from 6am to 8pm, subject to financial viability and demand. The cost per journey has not yet

been established. The method of booking, and how the company will organise routes has been made public.

The only cross County border service available will be to Barley Doctors Surgery. Direct transport into Hertfordshire or Cambridgeshire will not be possible.

The Chairman commented that it is vital this system is supported by the local community to ensure public transport is available for the future. The system appears to be flexible, and could accommodate commuters.

Mrs Potter requested assistance with this, as engagement with neighbouring parishes is needed to build a 'customer base' which the service can rely on.

This will be uploaded to the Chrishall web site, and will be an item for the annual parish meeting.

Uttlesford Community Transport Request for funding Following discussion, Councillors agreed that donations to Community Transport schemes and Citizens Advice Bureaux should be split equally between Royston and Uttlesford as both areas support Chrishall parishioners.

16.38 Chrishall Halls: update

Licences and agreements: Derek Ailes

The Village Hall Committee has produced a draft constitution which John Kay will discuss with the Committee, and will then report back to the next Parish Council meeting.

Old Village Hall: proposed name change: in recognition of the family which provided the land for the village hall, and also the gifting of the meadow to the parish, Councillors felt the new name should be 'Reed Hall', subject to agreement with the landowner.

Old Village Hall: building

The roof will need to be replaced. A decision needs to be made regarding whether to replace like for like, or to investigate the viability of a pitched roof which would cost less over a longer time scale.

It was proposed that the window frame is modified, with a brick wall to replace the bottom windows which continue to break at regular intervals.

PROPOSAL: That Chrishall Parish Council agrees to modify the main window in the Old Village Hall with the bottom of the window replaced with a brick wall. PROPOSED: John Kay, seconded Derek Ailes. AGREED AND RESOLVED UNANIOUSLY.

New Village Hall: grant funding has been achieved for new front doors.

Chrishall Pre-School:

Following discussion, Councillors agreed that in the interests of the parish, a 4 year break should be inserted into the licence to occupy which would enable renegotiation of the annual rental, subject to market pricing. It was made clear that the position of the building meant that prospective users would be limited, and the rent reflects this. Whilst it is recognised that Pre-School

provides a valued service to the parish, rental income must be sufficient to support the building and not prove to be a burden on the precept.

Derek Ailes will meet with Pre-School to discuss this and some other minor points.

16.39 Jigneys Meadow, pavilion & play area: update Hastoe Housing Association. Update

Funding issues have now been resolved, and documentation is now with the respective solicitors to proceed with land transfer to Hastoe Building Association. Hastoe is keen to commence with the building of the affordable housing.

A vote of thanks was offered to Derek Ailes for his hard work over many years. Derek commented that the first document he sent to the landowner to start the process was on the 1st March 2011 – five years to the day!

Pavilion: extension of use and building regs: on hold

Maintenance: ongoing.

The Cricket Club has expressed concern that the building requires significant cleaning before the first match which is scheduled for the 8th April. This clean will be undertaken on Saturday, 12th March.

Cricket Club has also expressed concern that it hasn't been included to the same level as the Museum and Library regarding the renovation.

An official launch will be organised to bring user groups together, and advertise the services available to the parish. A date has yet to be set.

Steve Parish reported that BT has installed ADSL2+. There are still many issues surrounding poor download speeds and internet access.

16.42 Essex Constabulary: consultation update

The clerk reported that despite written assurances from the Chief Constable that cuts to services would be reassessed if Central Government provided the same level of funding previously enjoyed, local media has reported that there will be cuts to PCSO number, and closure of local Police Stations. In his letter, the Chief Constable assured Chrishall Parish Council that the Saffron Walden Police Station would be retained. However, the Walden Local reported that it is to be closed as it has a rat infestation, and has been subjected to a chemical incursion. It will, however, be suitable to be turned into dwellings. John Kay commented that there will not be a custody suite in Uttlesford — anyone arrested will be transported to Braintree, which will have a significant impact on officer time and resources.
