Cllrs Parish and Slade commented that parents are utilising the Red Cow car park at school times, and are parking away from the junctions of High Street, Church Road and Palmers Lane. This is a very encouraging position. Chrishall Parish Council will request that the Head Mistress of the primary school, the Chair of the Primary School Governors, the Chair of the Pre-School Governors and Essex Police to attend the next meeting.

### 16.135 Policing in Chrishall:

The Essex Police and Crime Commissioner responded to the Parish Council letter that it was the responsibility of the Chief Constable to reply. A Police Inspector telephoned the clerk to explain the problems of policing with very limited financial resources, but advised that he would specifically focus on parking issues around the school. The clerk will make contact and ask for a representative to attend the next Parish Council meeting.
