The owner of Hillside Farm, Mill Causeway, Mr Smart, outlined his position regarding the letter he distributed across the parish describing the options he considers viable for the site. These include:

To go to appeal on the latest refused planning application for 5 dwellings. To put in a new application for one dwelling with ancillary buildings to fill up'

To relocate his business to Hillside Farm from Flint Cross.

Mr Smart received 18 responses to his letter, not all of which were copied to the Parish Council.

Mr Smart is keen to obtain support for the one house option from the parish and the Parish Council, and requested that an extraordinary meeting be held on his behalf to seek support.

Mr Smart suggested that the Parish Council could be gifted a small parcel of land in the order of 2m square, which would make the Parish Council an adjacent landowner, and that a covenant restricting development to that agreed would be drawn up for adjacent landowners.

Mr Smart commented that he had spoken at length with Tom Jackson, and the clerk, and had been advised that the site is considered to be unsustainable for housing development when considered against the NPPF by Uttlesford District Council. This consideration would remain whether the application was for one house, or more.

Uttlesford District Council has advised that greater consideration would be given to an application if Mr Smart was able to get agreement from the Parish Council.

Mr Smart pressed the point that he is seeking support for his one house proposal.

The Chairman thanked Mr Smart for his presentation, and commented that it was Mr Smart's prerogative to make his own decisions. *Mr Smart left the meeting at 8.40pm*

Chalk marks on houses: Tracy Slade commented that Herts County Council have deciphered the marks, which include information about households. Not all marks related to houses with dogs.

A suggestion for information about bonfires to be put into the newsletter was received.
