15.80 Chrishall School Hall & Village Hall: update

Derek Ailes reported that he has spoken with School Governors, who have agreed that the school will take over the old village hall commencing the new academic year at a rental value of £3,000 pa. Essex County Council has still to give permission.

15.81 Jigneys Meadow, pavilion & play area: update Hastoe Housing Association:

Following various delaying issues, it would appear that the proposal for development of four affordable and one market dwellings is back on track.

Pavilion: extension of use and building regulations:

Derek Ailes reported that he had visited Uttlesford District Council planning office four times to ensure that all documentation was correct. It was reported at the last meeting that UDC had provided the wrong form for completion, but that this had been accepted as it was UDC error.

The clerk had received a telephone call and a subsequent email, directing the map provided (which had been approved previously by the planning officers) was deemed to be incorrect as the lines were too thick, and encroached neighbouring properties. Derek Ailes will attend UDC offices as soon as possible.

Pavilion: repairs: New rear door required. The door has received a

temporary repair until the planning application is achieved.
